

CALIFORNIA ASSEMBLY BILL NO. 1200 (A.B. 1200) DISCLOSURE

At Felix Storch, Inc. (FSI), we take product safety seriously and are committed to complying with all federal and state laws applicable to our products.

The California Safer Food Packaging and Cookware Act of 2021 (A.B. 1200) enacted in the California Health & Safety Code beginning in Section 109010 requires that manufacturers of cookware must disclose on their website, any intentionally added chemicals on the [California's designated Candidate Chemicals list](#) that may be present in the handle or cookware surface that comes into contact with food.

A.B. 1200 defines "Cookware" to mean items used to prepare, dispense, or store food, foodstuffs, or beverages: pots, pans, skillets, grills, baking sheets, baking molds, trays, bowls, and cooking utensils. "Intentionally added" means that the manufacturer has intentionally added the chemical to the product and the chemical has a functional or technical effect in the product.

The following table(s) identify the products for which the A.B. 1200 website disclosure is required as well as links to the A.B. 1200 authoritative lists.

The identified products are not in violation of federal or safety regulations. A.B. 1200 does not specify any minimal content to trigger disclosures. Instead, it is a "right-to-know law" for the state of California that requires disclosure if any of the 3,000-plus chemicals are intentionally added. The extensive list includes common metals such as aluminum, chromium, copper, iron, nickel, and zinc, used routinely in manufacturing.
